

SUBJECT: ALFOODACT 009-2004 (**Updated**)- Frozen Beef Products, *E.coli* O157:H7
DATE ISSUED: August 30, 2004

2. BACKGROUND:

The Food Safety and Inspection Service (FSIS) has updated the original recall information on Quantum Foods. The original message recalled products that were produced on June 23 and June 24, 2004. The updated report recalls **only** beef sirloin steaks produced on June 23, 2004 and ground beef products produced on June 23 and 24, 2004. The update is reflected in the following paragraph.

3. PRODUCTION DATES/IDENTIFYING CODES:

The products subject to recall are beef sirloin steaks produced on June 23, 2004 and ground beef products produced on June 23 and 24, 2004. Each box bears the establishment code "EST. 213D" inside the USDA mark of inspection.

(1) Immediately inventory stocks to identify the above items.

(2) Secure in a "Medical Hold" status to provide assurance of no further issue/sale/use of the item.

(3) If product is found, it should be returned to the manufacturer, by way of the vendor representative.

(4) Products previously placed on "Medical Hold" should be released if they do not match the updated production dates stated in paragraph (3) of this message.

(5) This ALFOODACT applies only to product description and identifying codes outlined in paragraph (3) of this message.
