

14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)

THE GOVERNMENT HEREBY RENEWS SUBJECT CONTRACT AND INVOKES THE FOURTH OPTION PERIOD, APRIL 1, 2004 THROUGH 31 MARCH 2005.

- THE UNIT PRICES ARE CHANGED TO \$4.70 FOR MILITARY CONUS INSTALLATIONS, NAVAL SHIPS, AND NON-DOD INSTALLATIONS IN CONUS.
- THE UNIT PRICES ARE CHANGED TO \$5.70 FOR ALASKA, HAWAII AND GUAM.

3. CLAUSE 52.217.9P16, "EFFECTIVE PERIOD OF CONTRACT - INDEFINITE DELIVERY, INDEFINITE QUANTITY CONTRACT" IS MODIFIED AS FOLLOWS:

A. The effective period of this contract is from April 01, 2004 through March 31, 2005.

"Any supplies and services to be furnished under this contract shall be ordered by issuance of delivery orders by the activities designated in the schedule. Such orders may be issued from the period of April 01, 2004 through March 31, 2005."

5. The Government reserves the right to add other military and federal customers at no additional cost. The customers will be added based on a mutually agreed upon implementation plan. The transition period shall not exceed 30 days.

6. All Military customers will be assigned a STORES Contract number to be used in the DISMS and STORES systems for administrative and payment purposes.
