In accordance with 52.212-4(c) *Changes*, 52.216-9P15 *Economic Price Adjustment (EPA) – Established Market Price (Mar 2000)* DSCP is changed to revise paragraph (k) to read:

(k) The aggregate of the increases in any contract unit price under this clause shall not exceed 60% of the original contract unit price.

(1) If at any time during the term of the contract, the arithmetic computations suggest a **potential** price adjustment that would have caused the cumulative price increase to exceed 60% were it not for the required ceiling, decreases in the market indicator in the subsequent month(s) will **not** cause contract prices to be decreased until such a decrease would adjust the price to a level at or below the ceiling price.

(2) If at any time during the term of the contract, the contractor has reason to believe that in the near future a price adjustment under the provisions of this clause will be required that will exceed the current contract ceiling price, the Contractor shall promptly notify the Contracting Officer in writing of the expected increase. The notification shall include a revised ceiling the Contractor believes is sufficient to permit completion of remaining contract performance, along with appropriate explanation and documentation as required by the Contracting Officer.

(3) The Contracting Officer shall review the documentation justifying the proposed revised ceiling and notify the Contractor within thirty (30) days in writing of his decision.

(4) There is no percentage limit on downward adjustments under this clause.
