

1. In accordance with the subject contract, DSCP may issue National Indefinite Delivery Type Contracts (NIDTCs) for specific products to be distributed by Prime Vendors. The price charged by the Prime Vendor to the ordering activity will not exceed that cited in the IDTC, plus the Prime Vendor's negotiated distribution fee. At the time of the award and at other times when applicable, DSCP will provide the Prime Vendor with a list of all NIDTCs awarded and their terms and conditions. The Prime Vendor shall have 30 days within which to implement the terms and conditions of the awarded NIDTCs.

2. NIDTC SP0300-02-D-1134 for five (5) frozen potato items was awarded to Lamb Weston. Currently three (3) of these items are cataloged under the Ebrex Food Service subject contract.
