This is a no cost modification made within the terms and conditions of the contract to incorporate the following changes:

Clause DFARS 252.226-7001 - Indian Incentive Clause is incorporated by reference.

CTF-53 is established as a Kuwait customer. CTF-53 will require support for the occasional needs of small ships such as Coast Guard cutters and patrol boats with port calls requiring minor top-offs. These small ship customers (approximately 50-100 personnel on board) will at times require chill, FFV, dairy, dry provisions, some frozen meat items, IQ items and bottled water. Ordering should consist of items available from the PV catalog. Additional items can be added in accordance with procedures outlines on page 22 of the solicitation.
