Requirements for: Full Food Line Distribution for U.S. Troops located in Kuwait, Iraq & Qatar.
 This is a no cost modification made within the terms and conditions of the contract.
 The subject contract is hereby modified to incorporate the supplemental agreement between the parties for costs and conditions pertaining to the diversion of Government Furnished Material (GFM) and/or Prime Vendor Product from the PWC warehouse in Kuwait to the PWC warehouse in Jordan. PWC shall transport product from Kuwait to Jordan or from Jordan to Kuwait upon KO or COR written request for a specified amount. The required delivery time for each request is 7 days after notification of the requirement, unless otherwise noted by the requesting officer. PWC shall submit a manual invoice to the DSCP KO for each delivery within 30 days of the delivery. The invoice is required to be signed by the COR. The total price for each diversion from Kuwait to Jordan or from Jordan to Kuwait per Forty Foot Equivalent (FEU) temperature controlled truck is \$2500. This price includes customs clearance at the Kuwaiti, Saudi, and Jordanian borders and all other associated costs.
 Except as provided herein, all terms and conditions of the document referenced in Item 9A or 10A, as heretofore changed, remains unchanged and in full force and effect.
