A. Remove from the solicitation: Page 159, 161, and 163 and replace them with the pages found on page 3 through 5 of this amendment. Replacement pages reflect the following changes:

1. Page 159: Noted that the offeror's plans for ensuring compliance with the Berry Amendment will be also be evaluated under Factor II, Subfactor A (Product Availability).
2. Page 161: Slightly modified the language regarding evaluation of Quality Control and Assurance Procedures.
3. Page 163: Elaborated on the evaluation of socioeconomic considerations.

B. Remove from the revised schedule of items page 150, and replace it with page 6 of this amendment. Item 51 (French Toast) had previously been modified by amendment 0002 to change the quantity and unit of issue to reflect an individual unit "EA". This item is being revised again, with a new stock number. The new stock number has a unit of issue of PG, and provides a more detailed description of the item size and pack. Please note that this item is now item number 54 in the schedule of items.
