1. Page 93, Fish, Tuna, Canned – delete “white” and insert “light”.

2. Pages, 97-98, Items # 28 (orange juice, canned) and #29 (juice blend, canned) show a case size of 24/46 ounces. Offerors can offer on a pack size of 12 or 24 46/oz cans per case. Offerors must stipulate which size is being offered. Estimated quantity for 12 pack cases shall be changed from “300” to “600” cases. Offered quantities on the 24 pack cases shall remain the same. **Offered prices shall be evaluated on a 12/case quantity.**

3. Page 98, Items #30 (fruit cocktail canned) #31 (peaches, canned) and #32 (pears, canned) all show 24/case. Offerors can offer on a pack size of 12 or 24 cans per case. Offerors must stipulate which size is being offered. The Estimated quantities for the 12 pack shall be changed as follows: Item #30 from “300” to “600” cases; Item #31 from “500” to “1000” cases; and Item #32 from “400” to “800” cases. Offered quantities on the 24 pack cases shall remain the same. **Offered prices shall be evaluated on a 12/case quantity.**

4. Page 103, item # 64, nuts, peanuts - delete "salted" and insert "unsalted".
