"Presenters are to be key members of the company and active in the daily operations of the company and any ensuing contract. Professional orators are prohibited from taking part in this oral presentation.

Requests to substitute any presenter requires prior written approval of the Contracting Officer, which approval will not be unreasonably withheld. Such requests must be made in writing to the Contracting Officer at least 1 working day prior to the date and time set for the oral presentation, and must state with specificity the reasons for the substitution. Substitute presenters must also be key members of the company and active in the daily operations of the company and any ensuing contract, and must also be listed as such within the proposal."
