Subject solicitation is amended as follows:

1) On page 13 of the solicitation, Part VII

DELETE: The maximum ceiling will be one hundred and twenty-five percent (125)% of the estimated dollar value per contract period.

INSERT: For Zone 1 the maximum ceiling will be 24,000,000 per contract period.

For Zone 2 the maximum ceiling will be 4,000,000 per contract period.

The remainder of the clauses remains the same.

2) For Zone 2

Item 39 (soup/dehydrated) is deleted in its entirety.

3) All other terms and conditions remain the same.
