

# **CAUTION NOTICE**

## **ATTENTION CONTRACTORS!**

In response to two separate but related legislative actions, the Department of Defense (DoD) has established a “**DoD Central Contractor Registration (CCR)**” database. The Federal Acquisition Streamlining Act of 1994 (PL 103-355) requires the broad use of Electronic Commerce and Electronic Data Interchange (EC/EDI) by Federal Agencies and the Debt Collection Improvement Act of 1996 (31 U.S.C. 7701) requires electronics funds transfer (EFT) for payment. You therefore **MUST** be registered in the DoD CCR database if you want to continue doing business with any DoD Agency, regardless of whether EC/EDI is a requirement for award.

DoD has published guidelines for CCR in the DoD Federal Acquisition Regulation Supplement (DFARS). This new DFARS coverage can be viewed at <http://www.acq.osd.mil/dp/dars/dfarltrs.html>. The DFARS coverage on CCR applies to the award on **any** contract, basic agreement, basic ordering agreement, or blanket purchase agreement after May 31, 1998.

### NOTICE #3 TO OUR VALUED SUPPLIERS

The business practices of today reflect increased utilization of Electronic Commerce/Electronic Data Interchange providing more timely and cost effective ways of information exchange. The Defense Supply Center Philadelphia, Subsistence is migrating toward more and more use of the electronic mediums available to conduct business with you as our business partners.

DSCP has already implemented an ordering system known as STORES (Subsistence Total Ordering and Receipt Electronic System) from which the DSCP customers have the capability to order items electronically under this solicitation. For vendors who are not EDI capable, these orders are converted into facsimile format and will be sent in this fashion to your company from these customers. It is required that you provide the fax number for where these orders should be received, as these orders are being sent automatically from the computer. Space is provided at the end of each group for this number.

Your attention is directed to clauses 52.204-9P01 Submission of Information Regarding Electronic Data Interchange (EDI) (Mar 1994) DSCP (page 66) and 52.204-9P02, Information Relating to Electronic Data Interchange (EDI) (Mar 1994) DSCP (page 67).

DSCP is also working with the vendors to submit their invoices electronically, which should assist in faster and more accurate payments. As a matter of fact, the Defense Logistics Agency is undergoing a Business Modernization (BSM) initiative. This BSM initiative will change the way you currently invoice, ***and the manual paperwork will no longer be a viable way to invoice.***

Efforts have been underway for some time to bring a resolution for those who are not EDI capable to be able to accomplish Electronic Data Interchange with the invoices. Several alternatives are or will be available (see page 67).

(5) When the Military Medical Service or other inspection agency acceptable to the Military Medical Service determines that the sanitary conditions of the establishment or its products have or may lead to product contamination, the contracting officer will suspend the work until such conditions are remedied to the satisfaction of the appropriate inspection agency. Suspension of the work shall not extend the life of the contract, nor shall it be considered sufficient cause for the contractor to request an extension of any delivery date. In the event the contractor fails to correct such objectionable conditions within the time specified by the contracting officer, the government shall have the right to terminate the contract in accordance with the "Default" clause of the contract.

**ADDENDUM (Continued)**

## (b) Delivery Conveyances.

The supplies delivered under this contract shall be transported in delivery conveyances maintained to prevent contamination of the supplies, and if applicable, equipped to maintain any prescribed temperature. (Semiperishable supplies shall be delivered in a non-refrigerated conveyance.) The delivery conveyances shall be subject to inspection by the government at all reasonable times and places. When the sanitary conditions of the delivery conveyance have led, or may lead to product contamination, or they constitute a health hazard, or the delivery conveyance is not equipped to maintain prescribed temperatures, supplies tendered for acceptance may be rejected without further inspection.

**52.246-9P32 FEDERAL FOOD, DRUG AND COSMETIC ACT-WHOLESOME MEAT ACT (JAN 1992) DSCP**

(a) The contractor warrants that the supplies delivered under this contract comply with the Federal Food, Drug and Cosmetic Act and the Wholesome Meat Act, and regulations thereunder. This warranty will apply regardless of whether or not the supplies have been:

- (1) Shipped in interstate commerce,
- (2) Seized under either act or inspected by the Food and Drug Administration or Department of Agriculture.
- (3) Inspected, accepted, paid for or consumed, or any or all of these, provided however, that the supplies are not required to comply with requirements of said acts and regulations thereunder when a specific paragraph of the applicable specification directs otherwise and the supplies are being contracted for military rations, not for resale.

(b) The government shall have six months from the date of delivery of the supplies to the government within which to discover a breach of this warranty. Notwithstanding the time at which such breach is discovered, the right is reserved to give notice of breach of this warranty at any time within such applicable period or within 30 days after expiration of such period, and any such notice shall preserve the rights and remedies provided herein.

(c) Within a reasonable time after notice to the contractor of breach of this warranty, the government may, at its election:

- (1) Retain all or part of the supplies and recover from the contractor, or deduct from the contract price, a sum determined to be equitable under the circumstances;
- (2) Return or offer to return all or part of the supplies to the contractor in place and recover the contract price and transportation, handling, inspection and storage costs expended therefor; provided, that if the supplies are seized under either act, such seizure, at government option, shall be deemed a return of supplies within the meaning of this clause and thereby allow the government to pursue the remedy provided herein. Failure to agree to any deduction or recovery provided herein shall be a dispute of a question of fact within the meaning of the clause of this contract entitled "disputes".

(d) The rights and remedies provided by this clause shall not be exclusive and are in addition to other rights and remedies provided by law or under this contract, nor shall pursuit of a remedy herein or by law either jointly, severally or alternatively, whether simultaneously or at different times, constitute an election of remedies.

**52.247-9P24 F.O.B. DESTINATION (JAN 1992) DSCP**

Unless otherwise indicated in the individually numbered solicitation, only F.O.B. destination offers will be considered. Offers other than F.O.B. destination will be rejected.

**52.247-9P26 EVALUATION OF OFFERS (JAN 1992) DSCP**

- (a) Offers for less than the total estimated quantity of any single line item will not be considered.
- (b) Any offer that is conditioned or qualified by stipulation that the offer is to be considered only if prior to the date of award, the offeror receives (or does not receive) an award under another procurement, will be rejected.
- (c) Offerors are encouraged to offer on each and every item. When the offeror is not itself a producer of an item(s) arrangements may be made to obtain such item(s) from other approved sources.
- (d) Unless otherwise specified in the solicitation, single line items may be awarded in the best interest of the Government unless offers are specifically qualified. However, in addition to these factors, low offers on the individual items from offerors who fail to offer on all items may be foregone by the Government if acceptance (1) would prevent the Government from obtaining the majority of its needs for the majority of items under the solicitation and (2) would force the Government into a second procurement for items left unawarded.
