

CAUTION NOTICE

ATTENTION CONTRACTORS!

In response to two separate but related legislative actions, the Department of Defense (DoD) has established a “**DoD Central Contractor Registration (CCR)**” database. The Federal Acquisition Streamlining Act of 1994 (PL 103-355) requires the broad use of Electronic Commerce and Electronic Data Interchange (EC/EDI) by Federal Agencies and the Debt Collection Improvement Act of 1996 (31 U.S.C. 7701) requires electronics funds transfer (EFT) for payment. You therefore **MUST** be registered in the DoD CCR database if you want to continue doing business with any DoD Agency, regardless of whether EC/EDI is a requirement for award.

DoD has published guidelines for CCR in the DoD Federal Acquisition Regulation Supplement (DFARS). This new DFARS coverage can be viewed at <http://www.acq.osd.mil/dp/dars/dfarltrs.html>. The DFARS coverage on CCR applies to the award on **any** contract, basic agreement, basic ordering agreement, or blanket purchase agreement after May 31, 1998.

As a matter of fact, the Defense Logistics Agency is undergoing a Business Modernization (BSM) initiative. This BSM initiative will change the way you currently invoice, ***and the manual paperwork will no longer be a viable way to invoice.***

Efforts have been underway for some time to bring a resolution for those who are not EDI capable to be able to accomplish Electronic Data Interchange with the invoices. Several alternatives are or will be available (see page _____).
