Contract SP0300-01-D-2981 is hereby modified as follows:

a) The Government hereby renews subject contract and invokes the first option period for Land Based Activities in the Hawaiian Islands.

b) The distribution prices for all food and beverage items will remain the same as stated in the original contract for the first option period. The distribution prices are listed on the attached pages 3 through 8.

c) Clause 52.217-9P16 "Effective Period Of Contract-Indefinite Delivery, Indefinite Quantity contract" is modified to read: "The Effective period of this contract is from 26 June 2001 through 25 June 2002.

d) Clause 52.216-18 (a) is modified to read:

"Any supplies and services to be furnished under this contract shall be ordered by the issuance of delivery orders by the individuals or activities designated in the schedule. Such orders may be issued from 26 June 2001 through 25 June 2002 (first option period)."
