**IV. PRODUCT QUALITY**

The shelf-life policy reflected on page 38 of solicitation SP0300-02-R-4002 is supplemented with the following additional language as follows:

“For items manufactured with less than 14 days of original shelf-life, the vendor will deliver wholesome product with the freshest shelf-life available. The vendor will closely coordinate production and delivery times in order to insure that product will meet the end-use customer’s usage needs”
