The purpose of this modification is to change some of the standard contract distribution fees to reflect changes in the product mixture and to support new item programs, including adding new item category #51, ESL Milk ½ pints only to the Japan Zone. In addition to the lower prices for Q-Cogs represented by these revised rates, any item which falls into the Q-Cog category which is already currently catalogued under another category (such as certain candies and sodas,) will remain in its present lower priced category. Any necessary PBDF changes, including those instituted through P0009, will now utilize these prices as the standard or base figure for the distribution fees for these categories. The vendor will incorporate these new rates and the PBDF adjustments by 27 October 03. This will extend the period to which the PBDF decreases will apply by one week. Changes are as follow:

For Zone 1 JAPAN:

Category #2, Bakery & cereal products, Non Canned	\$5.00 per case
Category #19, Poultry, Bone-in, Raw & seasoned	\$0.37 per lb.
Category # 44, Q-Cogs	\$9.80 per case
