

THIS MODIFICATION IS ISSUED TO INCORPORATE THE LOADING AND STOWAGE OF SHIPS STORES BY THE FITTING OUT AND SUPPLY SUPPORT ASSISTANCE CENTER(FOSSAC). FOSSAC HAS CONTRACTED WITH A NON-MILITARY SOURCE TO ACCOMPLISH THIS MISSION. THAT FUNCTION IS NOW INCORPORATED INTO THIS CONTRACT.

CURRENTLY THE PRIME VENDOR IS RESPONSIBLE TO DELIVER PRODUCT TO THE "BROW OF THE SHIP", WHERE ACCEPTANCE BY THE GOVERNMENT TAKES PLACE. THAT REQUIREMENT DOES NOT CHANGE.
