- A. The first option year under contract SPM300-02-D-3021 is hereby exercised. Also extended are administrative contracts SPM300-03-D-3022, SPM300-03-D-N024 and SPM300-03-D-N025. The option will be effective November 3, 2002 through November 1, 2003. Customers affected by this option are in the states of Kentucky/Tennessee.
- B. The distribution prices for all food and beverage items will remain the same as stated in the base contract.
