1. REFERENCE CONTRACT MODIFIED AS FOLLOWS: FROM TIME TO TIME DURING THE LIFE OF THIS CONTRACT, DSCP WILL AWARD INDEFINITE DELIVERY TYPE CONTRACTS (IDTC'S) FOR ITEMS DISTRIBUTED BY THE PRIME VENDOR. THE PRICES CHARGED BY THE PRIME VENDOR TO THE ORDERING ACTIVITY WILL NOT EXCEED THE PRICE CITED IN THE IDTC, PLUS THE PRIME VENDOR'S DISTRIBUTION FEE. THE PRIME VENDOR SHALL HAVE 30 DAYS WITHIN WHICH TO IMPLEMENT THE TERMS AND CONDITIONS OF ANY IDTC'S AWARDED.
