The subject contract (SP0300-01-D-3005) updated to read as SPM300-04-D-3005 is hereby modified as follows:

1. The third (3) one (1) year option period under the subject contract (updated to read as SPM300-04-D-3005) is hereby exercised. The option period will be effective from 18 April 2004 through 17 April 2005.
2. The guaranteed minimum will be twenty-five (25%) percent of the estimated total option year dollar value of \$1,015,000.00. The maximum ceiling will be one-hundred-fifty (150%) percent of the estimated total dollar value of \$1,015,000.00.
3. SYSCO Intermountain Foodservice Inc has agreed not to increase the "Distribution Fees" for the third (3) one (1) year option period I/A/W information contained in their Business Proposal.

All other terms and conditions of the original agreement shall remain unchanged.

Except as provided herein, all terms and conditions of the document referenced in Item 9A or 10A, as heretofore changed, remains unchanged and in full force and effect.
